

What is the Measure C Renewal Technical Working Group?

The Measure C Renewal Technical Working Group (TWG) includes public agency staff, advocacy groups and modal advocates. By design, the TWG provides representation from Fresno County and each of its 15 cities. It includes other transportation related agencies, modal advocates, transit providers, community-based organizations, environmental advocates and concerned citizens.

During the Measure C Renewal process, the TWG will be working in parallel with Fresno COG's Regional Transportation Plan Roundtable, and will be evaluating transportation needs, current funding sources, and funding gaps by mode. This input and insight are the crux of the Measure C drafting process – with recommendations being assessed and reflected in the draft expenditure plan.

How was the Measure C Renewal Technical Working Group Formed?

FCTA and Fresno COG started the Measure C Renewal process by contacting a number of Self-Help counties that had recently renewed a measure, and we modeled our process and Executive Committee structure after these identified best practices. We went further than these Counties to ensure robust public participation by also establishing the TWG.

The TWG has similar responsibilities as the Regional Transportation Plan and Sustainable Communities Roundtable (RTP Roundtable), but while the RTP Roundtable is focused solely on transportation needs and priorities, the TWG will be focused on determining the recommended funding for each mode of transportation. Because of this overlap, the membership of the TWG drew largely from the RTP Roundtable. However, there were some missing elements on the RTP Roundtable that needed to be in the TWG. Some of these included:

- ✓ Aviation
- ✓ Emergency Services
- ✓ ADA/Seniors
- ✓ Construction
- ✓ Labor

Neither FCTA or Fresno COG staff selected members of the Measure C Renewal Technical Working Group members. Rather, FCTA and Fresno COG approached local agencies, groups and constituencies for recommendations on potential representatives to join the TWG. Seated members of the TWG are reflective of those specific recommendations. While staff exercised no control or influence on the TWG member selection, it was hoped they would represent the economic, educational, environmental, socioeconomic, and reflect the overall makeup of our community. The Technical Working Group does indeed meet those expectations and is at the center of the drafting process for the Measure C Renewal effort.
